EXPRESS CONTRACTUAL ASSUMPTION OF ALL RISKS, WAIVERS, AND RELEASE FROM ALL LIABILITY FOR ANY NEGLIGENCE / INDEMNITY FOR ALL THIRD PARTY CLAIMS. Myself and my child or legal charge (here forward referred to as "We") know that skateboarding and inline skating are inherently dangerous sports and activities in which we choose to participate at our own risk. We are aware that the usual risks, hazards, and dangers of personal injury, death, and disability or property damage and loss, necessarily increase when using ramps, rails, curbs, steps, half-pipes, or any other structural device. We know that risks, hazards, and dangers include but are not limited to: uncontrollable boards, falling, jumping, landing, performing tricks, colliding with other users, staff, and spectators. We also understand that these risks, hazards, and dangers inherently increase when others, whether or not of the same level of experience or skill, are present at the same time and using the same facilities. (all of the above defined activities are collectively referred to throughout this agreement as "hazardous activities.")

By this agreement, It is our intention to relieve the One-Eighty Teen Center and First Baptist Church of Lodi (collectively referred to throughout this agreement as "One-Eighty") of any duty to any participation and do assume the entire risk of any of the Damages which might occur as a result of the use of or presence at One-Eighty. By this agreement, We also intend to release discharge and absolve One-Eighty from any and all liability for any passive or active negligence whatsoever by One-Eighty and to waive or relinquish any claim of action against One-Eighty for any loss, claim, damage, personal injury, disability, death, medication, and any other type of expense or property damage or loss (collectively referred to throughout this agreement as "Damages"), caused by any negligence of One-Eighty and promise not to sue or exercise any legal right to seek damages from One-Eighty. In consideration of utilizing the One-Eighty Teen Center facility, we agree as follows:

1. As to participation in any activity, including but not limited to: the Hazardous Activities and as to any and all liabilities for the Damages which we may suffer or incur due to any cause whatsoever, while in the interior or exterior of the premises of the One-Eighty facility we agree:
 - a) To waive any and all claims for Damages that we may have against One-Eighty, their members, managers, employees, officers, associates, agents, contractors, volunteer sponsors, vendors, or exhibitors, or any other person or company in any way associated with One-Eighty, and
 - b) To release One-Eighty from any and all liability for the Damages that we may suffer or incur, or that my next of kin may suffer as a result of our participation in any activity at the center, including but not limited to the Hazardous Activities while at the center; and
 - c) To hold harmless and indemnify One-Eighty from any and all liability for the damages to any third party resulting from our participation in any activity, including but not limited to, the Hazardous Activities while at One-Eighty.
2. This waiver and release of liability and indemnification agreement (collectively referred to hereafter as "waiver and release") shall be effective and binding upon our heirs, next of kin, family, relatives, guardians, conservators, executors, administrators, trustees, and assigns in the event of injury, disability, or death.
3. We hereby certify that said participant is less than 18 years old. We have completely read and understand this Waiver and Release and its terms. Prior to signing this waiver and release, we assume all risks and waive and release certain rights, that we, our heirs, next of kin, family, relatives, guardians, executors, administrators, trustees, and assigns may have against the One-Eighty Teen Center and the First Baptist Church of Lodi.
