If the participant (or parent/guardian) and the activity sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution in accordance with the rules of the American Arbitration Association.

HOW DO I SIGN UP?

HOW DO I EARN CREDITS?

- Weekly Timecard Available during check-in at the front desk. It is your responsibility to update. All accounts are finalized each week and earned credits are deposited into your account.
- Attendance 50¢/day and Friday night visiting One-Eighty Teen Center
- Guests \$1.00/guest you bring to the One-Eighty Teen Center
- Service Projects \$2.00/hour of approved service projects
Service projects are approved by Operations Manager (Kenny McGregor) or Teen Center Director (Doug Collins) ONLY and granted to those who are eager to serve, learn a new skill, and work hard.

HOW DO I APPLY CREDITS TO MY DESIRED ONE-EIGHTY TRIPS?

Once a week our One-Eighty Administrator will tally your credits earned, produce a ledger, and deposit the credits into your account, which will be your account balance. It is your responsibility to request a withdraw and have your credits applied to your desired One-Eighty trip on your weekly timecard.
